- 3. The Apprentices will be paid stipend during the training period as per the guideline of Directorate General of Employment and Training, Ministry of Labour and Employment.
- 4. The selected candidates will have to pass the prescribed medical examination and physical fitness before engagement, for which the candidates will have to pay a sum of Rs. 24/-towards medical examination fee.
- 5. The selected candidates will be governed by the Apprentices Act 1961. The candidate who is selected (if Major) will have to execute a contract of apprenticeship or by his father/guardian in case the apprentice is a minor. In case the Apprentice fails to complete the training for reasons not acceptable to the Apprenticeship advisor, he or his father/guardian will have to pay the cost of training to the employer as decided by the Apprenticeship Advisor in accordance with the terms and conditions of the contract.
- 6. There is no guarantee for appointment or employment after completion of the training.
