Subject : Filling up of the vacant posts in the Central Administrative Tribunal on deputation basis It is proposed to fill up the following posts in the Central Administrative Tribunal on deputa-

tion basis initially for a period of one year which is likely to be extended or curtailed in administrative exigencies from amongst the serving Govt. Servants and/or on re-employment on contract basis for a period of one year initially from amongst the retired Government Servants. The Pay and allowances and other terms of deputation of the officers/officials

selected for the said posts will be regulated in accordance with the instructions contained in the Department of Personnel & Training OM No.6/8/2009-Estt.(Pay-II) dated 17/06/2010 as amended from time to time. The employees of Central Administrative Tribunal are eligible for

and may continue to retain General Pool Residential Accommodation as per extant rules.

The name and number of posts, classification, place of posting, tenure, scale of pay and eligibility criteria for filling up of these posts on deputation basis are as under-I. REGISTRAR (02)

Group 'A' (Gazetted) in the scale of pay of Pre-revised Pay Band-4 (₹ 37400-67000 Plus Grade Pay ₹ 8700). The tenure of deputation would be for a period of three years. Selected Officer may be posted in the Bench where the vacancy would be available at that relevant point of time. The vacancies in the grade are presently available at Allahabad, Bengaluru,

Chennai and Kolkata Benches of the Tribunal. Eligibility Criteria:-(i) Officers possessing a degree in law and holding :-

Grade Pay ₹ 4800). Selected Officers may be posted in the Bench where the vacancy would be available at that relevant point of time. Vacancies in the grade are presently available at Ahmedabad, Allahabad, Chennai, Cuttack, Guwahati, Hyderabad, Jabalpur, Jaipur, Jodhpur, Kolkata, and Mumbai Benches of the Tribunal.

The Armed Forces Personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be

considered. Such persons would be given deputation terms up to the date on which they are due to release from the Armed Forces, thereafter they may be continued on re-employment.

2. The period of deputation in respect of above posts including the period of deputation in

another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed three years. Age limit : (i) Deputation: The maximum age limit for appointment on deputation shall not exceed 56 years as on the closing date for receipt of applications.

(ii) Re-employment on contract basis: The maximum age limit for the re-employment on contract basis is 64 years.
