Essential : Graduate with Diploma in Management with 3 years' experience in Pay Band No. 2 of Rs. 9300-34800 with Grade Pay of Rs. 4600/- OR 5 Years' service in the Pay Band No. 2 of Rs. 9300-34800 with Grade Pay of Rs. 4200/- in responsible capacity in Stores & Purchase.
